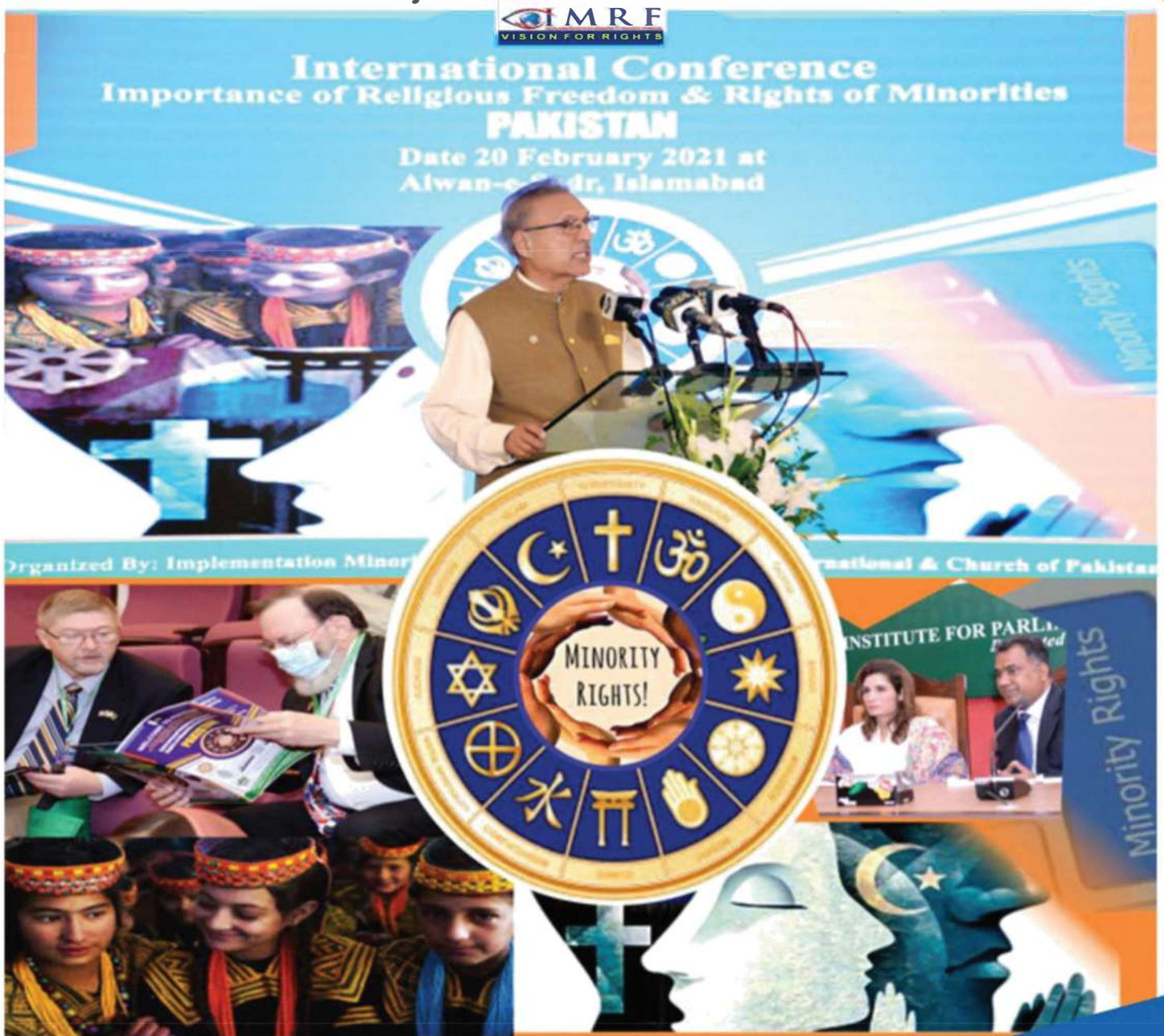
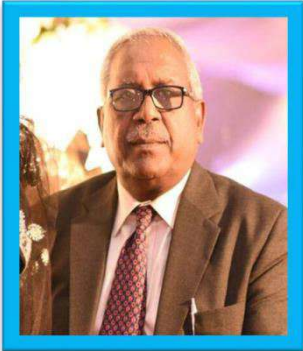

IMRF is Non-Profit, Non-Political and Non-Religious Forum working for the implementation of the Rights of Minorities in Pakistan.

Aims & Objectives

1. It is the responsibility of the IMRF to raise voice for the rights of the minorities at every Forum through Seminars, Conferences, Electronic & Print media, and Social Media as well so that lack of awareness and ignorance about the fundamental rights might be abolished and the status of the religious minorities deserves may be implemented and executed.
2. Coordinator shall be deployed in all provinces to make sure the awareness program to be organized by the IMRF so that the awareness shall be provided to the Government officials and the Masses as well.
3. It is also the responsibility of the IMRF to constitute delegates to conduct the meeting with the Government Officials both on the Federal and Provincial Level.
4. It is further the duty of the IMRF that it shall keep on working for the implementation of the vulnerable Judgment of the Supreme Court of Pakistan and in case of any failure, IMRF shall approach the Full Bench of The Honorable Supreme Court of Pakistan till its implementation into its true letter and spirit, More over this bench is constituted that it shall hear the complaints of the minorities and IMRF shall take all these applications and complaints and shall place before the Honorable Bench of The Supreme Court of Pakistan as directed in the judgment.
5. The IMRF will provide free legal aid to the deprived sections of minorities.
6. The IMRF shall announce and conduct an award ceremony “Justice Alvin Robert Cornelius” annually.

The main object of establishing “Implementation Minorities Rights Forum” is to assist, guide and attain the rights of the minorities in Pakistan. Its purpose is to execute the rights awarded by the federation, the honorable Supreme Court of Pakistan, Provinces, High Courts and other institutions to raise the voice for the rights of minorities and also provide awareness about their fundamental rights because there is decline of the awareness of the basic rights of the minorities in Pakistan.

The Honorable Supreme Court of Pakistan said, we find that the incidents of desecration of places of worship of minorities could be warded off if the authorities concerned had taken preventive measures at the appropriate time. The Court also found that the inaction on the part of law enforcement agencies was on account of the lack of proper understanding of the relevant law.

“The Honorable Supreme Court of Pakistan got astonished when the Advocate General Sindh said that burning or disgusting the worship places of the minorities is neither blasphemy nor it is a crime according to the Pakistan Penal Code. When He was asked to read Section 295 PPC and he had nothing to say but to keep quiet. Where it is written that any place of worship whether it belongs to any religion is sacred and violating its sanctity is an offence.”

There is a general lack of awareness about minority rights among the people and those entrusted with enforcement of law are also not fully sensitized to this issue either. It needs to reiterate that IMRF is the biggest forum in Pakistan working on the implementation on the direction of

Supreme Court on minorities rights, by the grace of God IMRF has successfully secured the relief claimed from the Honorable Supreme Court of Pakistan including state institutions as and when required. IMRF achieved its all goals. IMRF is the applicant of all cases mentioned below

Vision of Minority Rights



Importance of Religious Freedom & Rights of Minorities

Religion has played an important role in human history, and faith has influenced the minds and actions of individuals, societies and nations down the ages. By freedom of religion and belief is meant the right of a person to follow a doctrine or belief system which, in the view of those who profess it, provides spiritual satisfaction. However, it is impossible to define the term 'religion' in rigid terms. The freedom of religion must then be construed liberally to include freedom of conscience, thought, expression, belief and faith. Freedom, individual autonomy and rationality characterize liberal democracies and the individual freedoms thus flowing from the freedom of religion must not be curtailed by attributing an interpretation of the right to religious belief and practice exclusively as a community-based freedom. The freedom of religion and conscience has been protected in several treaties and declaration⁴. Article 18 of the United Nations Covenant on Civil and Political Rights, 1966 provides as follows: -

“Everyone shall have the right to freedom of thought, conscience and religion. This right shall include freedom to have or adopt a religion or belief of his choice, and freedom, either individually or in community with others and in public or private, to manifest his religion or belief or belief in worship, observance, practice and teaching.”

United Nations Declaration on the Rights of Minorities

Every country has national or ethnic, religious and linguistic minorities within its borders. Persons belonging to minorities aspire to participate in the public, social, economic, cultural and religious life of the societies in which they live, on an equal footing with the rest of the population.

Twenty years ago, UN Member States adopted unanimously the Declaration on the Rights of Persons Belonging to National or Ethnic, Religious and Linguistic Minorities, an acknowledgment that a gap existed in minority rights protection. This gap persists today.

The Minority Rights Declaration established that States have an obligation to acknowledge and promote the rights of minorities to enjoy their own cultures and identities, to profess and practice their own religions and use their own languages.

The Declaration ushered in a new era for minority rights. It sets essential standards for protection and offers guidance to States as they seek to realize the human rights of minorities.



Message by Mr. Samuel Payara

(In the light of Honorable Supreme Court of Pakistan Judgement 19th June (PLD 699) 2014.)

The right of religious conscience conferred on every citizen is a right conferring three distinct rights i.e. Right to Profess, Right to Practice and Right to Propagate. What this means is that Article 20 does not merely confer a private right to profess but confers a right to practice both privately and publicly for their religion. Moreover, it confers the additional right not only to profess and practice his own religion but to have the right to propagate their religion to others. It is important to note that this propagation of religion has not been limited to Muslims having the right to propagate their religion but this right is equally conferred on Non-Muslims to propagate their religion to their own community and to other communities. This should not be seen as a right to encourage conversions but more importantly, should be seen as a right against forced conversions or imposing beliefs on others because if all citizens have the right to propagate then no citizen has the right of forced conversion or imposing beliefs on others.

Article 20 of must then be interpreted to guarantee the rights of the community as well as the right of the individual against those from his own or other religious communities – the ultimate goal being the eradication of religious intolerance in the society. English political philosopher John Stuart Mill in his treatise ‘On Liberty’ (1859) stated that “the great writers to whom the world owes what religious liberty it possesses, have mostly asserted freedom of conscience as an indefeasible right, and denied absolutely that a human being is accountable to others for his religious belief. Yet so natural to mankind is intolerance in whatever they really care about, that religious freedom has hardly anywhere been practically realized, except where religious indifference, which dislikes to have its peace disturbed by theologically quarrels, has added its weight to the scale. “The spirit of pluralism reflected in the Holy Quran constantly points out that Prophet Muhammad ((PBUH)) had not come to cancel the older religions, to contradict their Prophets or

to start a new faith. To the contrary, His message is the same as that of Abraham, Moses, David, Solomon or Jesus. The cherished goal of creating a more pluralistic society where fundamental rights are respected would continue to elude us unless we realize that we are living in a world of globalized interdependence, a world of interconnectivity, of cyber space, of shrunken distances, of cross border migration, and a world of rapidly changing cultural identities. We are all members of one race of humans with common challenges, and we cannot confront these challenges without forging a common alliance. This paradigm shift in the world around us can be achieved at the international and domestic levels SMC No. 1/2014 etc. 30 only by discouraging sectarian, racial and ethnic biases which are violative of shared values and fundamental rights, and by the promotion of and strict compliance with these values and rights.

Religion has played an important role in human history, and faith has influenced the minds and actions of individuals, societies and nations down the ages. By freedom of religion and belief is meant the right of a person to follow a doctrine or belief system which, in the view of those who profess it, provides spiritual satisfaction. However, it is impossible to define the term 'religion' in rigid terms. The freedom of religion must then be construed liberally to include freedom of conscience, thought, expression, belief and faith. Freedom, individual autonomy and SMC No. 1/2014 etc 16 rationality characterize liberal democracies and the individual freedoms thus flowing from the freedom of religion must not be curtailed by attributing an interpretation of the right to religious belief and practice exclusively as a community-based freedom.

The freedom of religion and conscience has been protected in several treaties and declaration 4. Article 18 of the United Nations Covenant on Civil and Political Rights, 1966 provides as follows: -

“Everyone shall have the right to freedom of thought, conscience and religion. This right shall include freedom to have or adopt a religion or belief of his choice, and freedom, either individually or in community with others and in public or private, to manifest his religion or belief or belief in worship, observance, practice and teaching.”

One of the foundational aims of all the major religions in the world has been to eradicate this bias and to preach humanism. However, in practice on account of misinterpretation of some of the religious tenets, religion instead of liberating human beings from these curses of bias have enslaved them which has resulted in violence and human misery. Governments and parliaments in almost all modern democracies have endeavored to undo the injustices done to the minorities in the past.

In 1954 the U.S. Supreme Court in the case reported as Brown Vs. Board of Education of Topeka (347 US 483 (1954) abolished segregation in schools and ensured implementation of its judgment by directing the dispatch of federal troops to the concerned State. In the said judgment, the U.S. Supreme Court came a long way from its earlier judgment in Dred Scott Vs. Sandford (60 U.S. 393 (1857) where a colored was refused a status of a citizen. In not-too-distant past, the country elected a colored as its President i.e., Mr. Barack Hussein Obama.

Constitution of Pakistan guarantees equal rights to all citizens. Quaid-e-Azam laid the foundation for religious freedom and rights of minorities. She quoted Quaid's statements, you are free; you are free to go to your temples, you are free to go to your mosques or to any other places of worship in the State of Pakistan. You may belong to any religion or caste or creed – that has nothing to do with the business of the State". The white part of flag of Pakistan represents minorities living in Pakistan. If you look at all religions, Prophet Muhammad (PBUH) or Jesus Christ, they all stood for injustice., all stood for the rights of minorities. If you study any religion, the teachings are the same. Centuries ago, the people used to live together in harmony, so why are we divided today. We really need to think on it. We are confronted with many challenges. Most recently COVID 19 is a wake up, shake up call. Most developed countries and developing countries have become equal. The inhuman actions in occupied Kashmir have made more than 80,000 Kashmiri children orphans and women are molested daily. The Kashmiri people have a miserable existence in the world's heaviest militarized zone, more so than Gaza, Iraq and even Afghanistan. Over 700,000 Indian soldiers are stationed in the valley



This gives us an opportunity to rethink on our lives. Even if one person in the planet is affected with COVID 19, it will spread. So rich countries have to take care of poor countries. The ten commandments or farz of Islam, they all teach us an integrity, respect, tolerance, harmony, coexistence, and forgiveness. These are the principles which we need to practice. The world is now more divided as it was; Islamophobia is all time high; racial discrimination is all time high. This conference should address these issues. She also suggested seek first to understand and then to be understood and emphasized on taking care of all phobias (Islamophobia, cultural phobia, class phobia etc.). The issues of religious freedom and communal violence in South Asia are complex and deeply rooted in history. Issues in Pakistan range from a lack of access to education, sanitation, transportation and health care, to occupational discrimination and more direct experiences of violence such as abductions and forced conversions, accusations of blasphemy, targeted killings, and frequent attacks on places of worship. Prime Minister Imran

Khan is committed to making changes that will help uproot support for extremism and enhance protection for religious minorities. From the time Imran Khan took the office of the Prime Minister, he had persistently claimed that minorities in Pakistan are equal citizens and were under state protection in many of his tweets and interviews. The opening of Kartarpur corridor for Sikh pilgrims and government support to protect and renovate worship places of religious minorities are good examples. 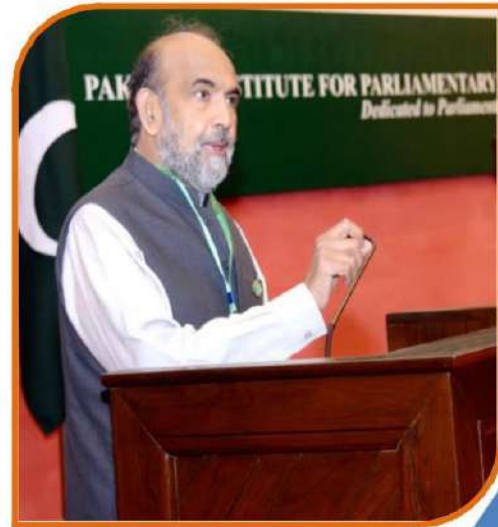

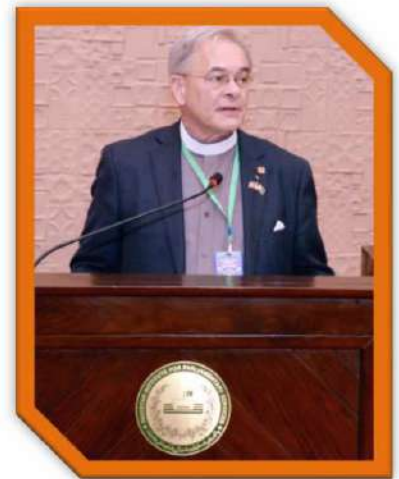

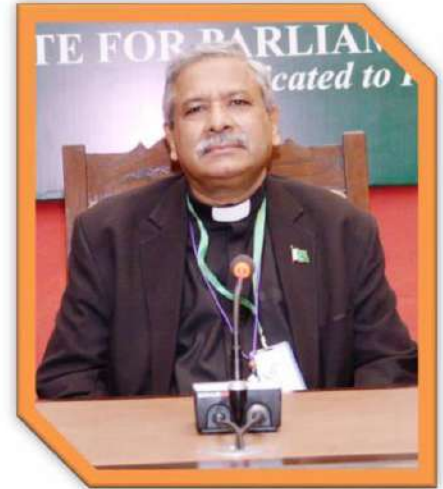

The session started with recitation from Holy Quran and a joint prayer by representatives from Christian, Hindu, Sikh, Bahai, and Kalash Community. It was followed by an introduction of the Conference and declaration of UN on the rights of minorities, read by Rev. Anil John.



When it comes to rights for religious minorities, Pakistan is the focus of much international controversy, even though Pakistan's religious minorities constitute just 3.7% of its total population. These rights include freedom of religion, economic opportunities, political representations, and socio-identical acceptability of minorities by the Muslim majority and state. Freedom, individual autonomy and rationality characterize liberal democracies and individual freedoms thus flowing from the freedom of religion I am just not be curtailed by attributing an interpretation of the right to religious belief and practice exclusively as a community-based freedom. The freedom of religion and conscience has been protected in several treaties and declaration.



Dr. Joseph Paul Knight Scholar from US

I am delighted to be here for participation in this conference arranged by IMRF & Ministry of Religious Affairs and Inter-Faith Harmony. The freedom of religion protects rights of all individuals. In 1947, Mohammad Ali Jinnah was the first person to recognize rights of minorities. Jinnah's speech of 11 August 1947, laid the foundation for the rights of religious minorities living in Pakistan. The

Universal Declaration of Human Rights addresses four **key areas**: personal rights, such as freedom and equality; relationship rights, such as nationality and having a family; spiritual and political rights such as the freedom of religion and voting; and economic, social and cultural rights, which cover work, wages, education and social security. The Marrakesh Declaration is made in January **2016** by "more than 250 Muslim religious leaders, heads of state, and scholars", which champions "defending the rights of religious minorities in predominantly Muslim countries. Actual compliance to these declarations is a challenge and still there are many gaps between different sects and religious leaders. Therefore, peaceful co-existence is necessary. According to Gospel of Matthew, Jesus said, 'Love your neighbor as yourself' and pray for those who hurt you. Let us love each other and may peace prevail in Pakistan.





Mr. Khalid Jawed Khan
Attorney General, Government of Pakistan

The founder of the nation, Quaid-e-Azam Mohammad Ali Jinnah set the tone for loving and caring minorities in his historical speech of 11 August 1947. Compliance with the statement of Mohammad Ali Jinnah and international obligations is need of the day. **Article 14(1)** of the Constitution confirms that "the dignity of man and, subject to law, the privacy of home, shall be inviolable." As a fundamental constitutional right, the right to privacy is meant to take precedence over any other inconsistent provisions of domestic law. **Article 20** of the Pakistani Constitution guarantees freedom of religion. Pakistan is a signatory to the UN Charter of Human Rights. The government is under obligation to safeguard the fundamental rights of all without discrimination based on religion, faith, or belief. **Article 21** safeguards against taxation for purposes of any particular religion. **Article 22** safeguards as to educational institutions in respect of religion, etc. (b) no citizen shall be denied admission to any educational institution receiving aid from public revenues on the ground only of race, religion, caste or place of birth. **Article 26** clearly highlights that there shall be no discrimination against any citizen on the ground only of race, religion, caste, sex, residence or place of birth.



Tassaduq Hussain Jilani, the former Chief Justice of Pakistan, was a strong proponent of civil liberties and fundamental rights, authoring landmark decisions on women's rights, honour killings, and the right to education. He also authored the *suo moto* decision on the protection of minorities and freedom of religion after the Peshawar church attack in 2013, widely held as the broadest interpretation of religious freedom laws in Pakistan's history. The government of Pakistan has taken number of good initiatives for the protection of religious minorities living in Pakistan. I pay tribute to unsung minority heroes and reaffirm commitment of Pakistani government to protect minorities.





Mr. Herman Roborgh
Religious Education Scholar, Australia

The creation of Pakistan in 1947 brought hopes not only to Muslims but also to religious minorities. The founding father, Quaid-e-Azam Mohammad Ali Jinnah, envisioned a state that represents all communities in policy making. Often, we study religion to defend our own point of view. We look religions from our own perspective. There are many good gestures shown by the government. I have experienced that there is a Muslim voice for the protection of equal citizenship rights for religious minorities, and it is encouraging that at least some Muslim religious leaders and other groups recognize they need to play an active role in this regard.

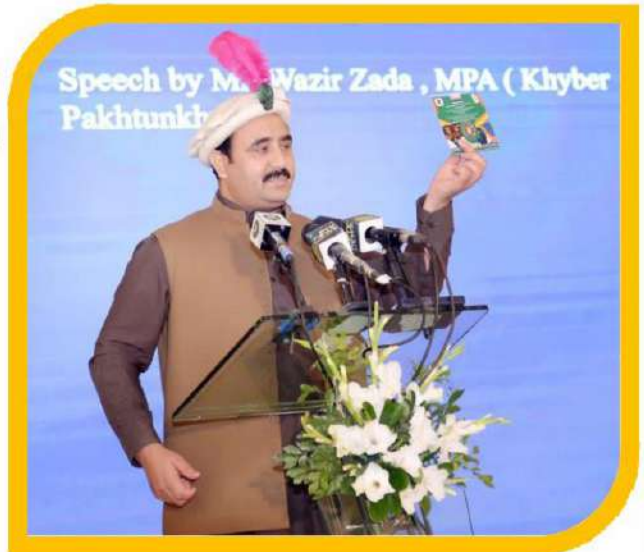

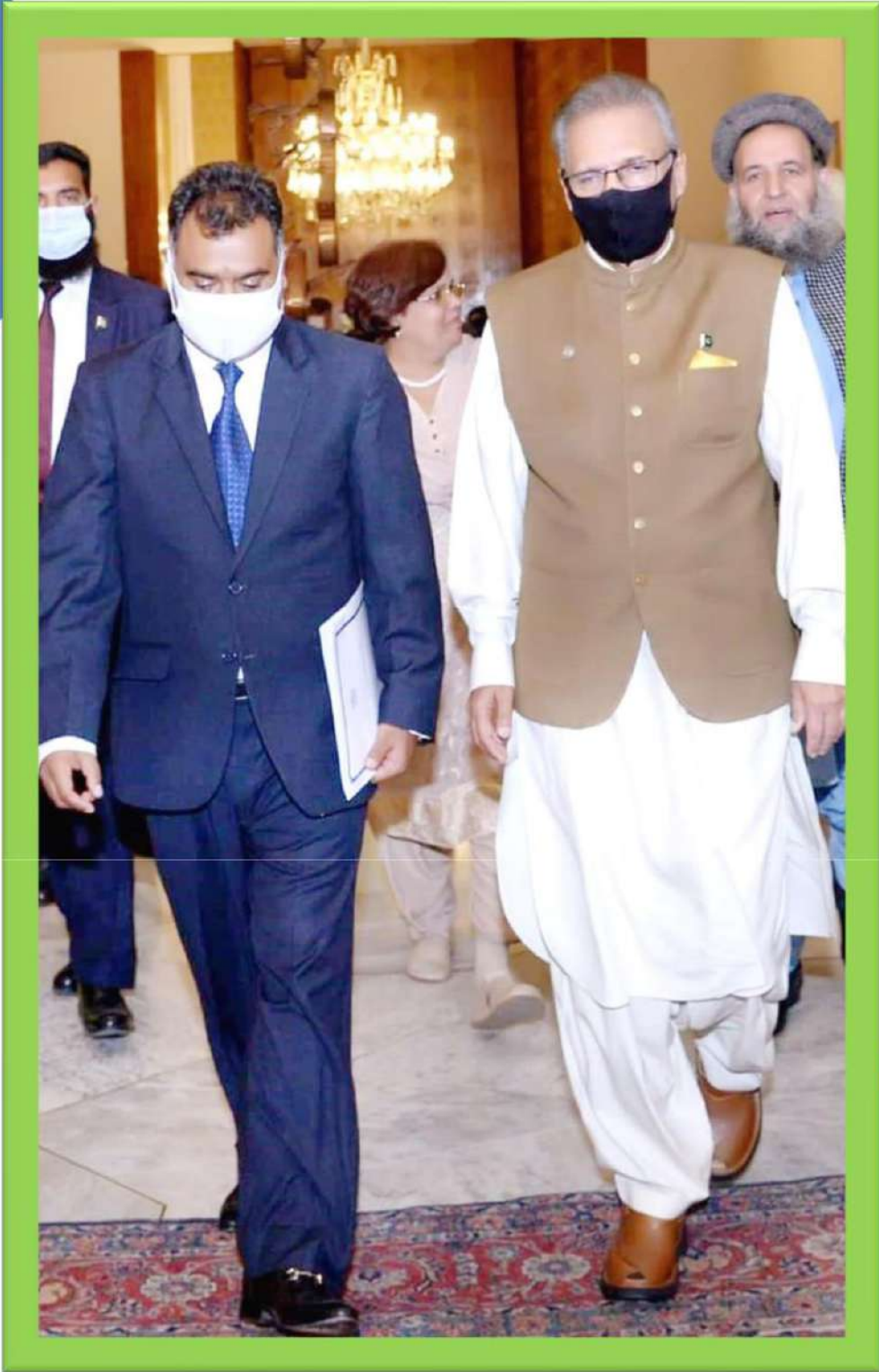

Honorable Mr. President, Minister Qadri, Member of Parliament Ms. Ruth, honorable Maulana Azad, professor Qibla Ayaz and esteemed Chair of IMRF, esteemed faith leaders, academics, colleagues and partners from near and far. I am honored to be here today to offer my concluding remarks to the two-day conversation on the Importance of

Religious Freedom and Rights of Minorities. I am glad that so many parts of Pakistani society join hands together thanks to IMRF and Samuel Payara to start a conversation on how to exchange knowledge, awareness and concrete suggestion on how to ensure safe, secure, peaceful and tolerant societies for ALL citizens regardless of faith, race, creed or gender.

We as the European Union are committed to advance both Knowledge-exchange and inter/intra-faith harmony and co-existence globally. In Pakistan, we have defined interfaith harmony as one of the key priority areas in our strategic engagement plan with Pakistan and EU's foreign policy and development cooperation with Pakistan is driven by a value-based agenda in which Freedom of Religion or Belief is a key priority.

In 2019 I was appointed ambassador to Pakistan, the same year that the Strategic Engagement Plan was signed between European Union and Pakistan. This plan or rather roadmap is important because it upgraded EU-Pakistan relationships and reaffirmed our **joint** determination to further strengthen the long term, forward looking and broad-based partnership for peace, development and prosperity. A partnership which is rooted in shared values, principles, and commitments. The SEP is based on the **principles of the UN Charter, international norms and law, principles of mutual respect and trust, as well as common interests**. It is also building upon the progress achieved so far under the Cooperation Agreement between the European Community and the Islamic Republic of Pakistan on partnership and development of 2004, as well as the EU-Pakistan Summit Joint Statements of 2009 and 2010, and the 5-Year Engagement Plan (2012 - 2017).

As mentioned, two key priorities in this plan relevant for our discussion today include:

1. Promoting and protecting human rights including minority rights
2. Enhancing intercultural and inter-faith dialogue and understanding to promote tolerance and harmony, in particular through a mutually beneficial exchange of knowledge, people-to-people contacts and education.

Since I have been appointed Ambassador to Pakistan, I have committed to the above goals by reaching out to those with whom we can realize these priorities including politicians, civil

society, religious leaders, and representatives from minority faiths. What makes my job as ambassador a bit ‘special’ is that it’s also about meeting, listening to and discussing with many religious actors and – leaders.

One milestone in our ongoing efforts in this area has been catalyzing conversations together with the Council of Islamic Ideology about the role of academic institutions in promoting peaceful and tolerant citizens and societies. I believe that education is key to uniting nations and reforming societies into progressive and inclusive societies. University campuses can contribute towards a building a culture of peace, diversity and harmony and of a tertiary education in building a knowledge economy. Being at the center of ideas, innovation and knowledge creation, universities must play a vital role in inculcating the values of responsible citizenship, peace, tolerance, harmony, pluralism and co-existence amongst youth – the potential future leaders of society.

A more recent initiative and milestone has been a roundtable on interfaith and intra-faith harmony co-organized by EU and Maulana Azad on December 9, 2020, which culminated in a Joint Statement (which all of you have in your hands). While the statement has 8 equally important agreed commitments, I believe one commitment that is of key importance to any society is no. 5 “... *the condemnation of hate speech against religion, race and colour which can result in any form of harm*”.

- Today, I would like to share a few reflections and two points with you:
- **Firstly, research informs us that 80% of the world’s population, women and men, profess to belong to one religion or another.**

Religious actors, including religious leaders are influential, often among the most critical cultural gatekeepers in many societies and communities around the world. They can and must play an important role in advocating for or against – gender equality and also gender-based violence and harmful practices, such as child marriages or forced conversions. There are exceptions to this global trend, notably in Europe, where I have witnessed people turning away from religious affiliations – sometimes because of regressive opinions on gender equality held by religious authorities and communities.

For all the above reasons, it’s imperative to take into account, and critically appreciate when we speak about the rights of religious minorities, why and how religions intersect with the lives of citizens, women, men, girls and boys positively or negatively?

Secondly, Human Rights actors and religious actors are getting closer.

My second point is that there are many encouraging initiatives connecting human rights actors and religious actors/leaders. Just look around us here today. I wish to mention the unprecedented roundtable again organized on December 9, 2020 by Maulana Azad, myself and convened by the ex. Chairman of CII Dr. Qibla Ayaz in the presence of Minister Qadri, religious leaders and human rights actors and European diplomats as a prime example that while the conversations may be hard, it is possible and its necessary. The EU’s Fundamental Rights Agency (FRA) is also stepping in the area of religion and human rights in Europe, which is both necessary and *important. In 2019 EU’s former Foreign Minister Mogherini launched a Global Exchange platform on Religion and Society, some of you here today were present at the launch. This*

platform reaffirmed the need for different actors (religious and non-religious) to actively exchange positive experiences of inter/intra-faith harmony and co-existence.

I am a firm believer that bringing closer religion and human rights can open innovative and unexpected common grounds which is something EU is committed to in Pakistan. My intention is to continue catalyzing inter/intra-faith roundtables with Pakistani partners during my tenure and I hope these initiatives can generate real changes in peoples' lives.

Thank you very much for your attention and congratulations to the organizers and participants for committing to finding ways to promote religious freedom – we all have to do our part. I am looking forward to continue engaging with all of you.

“Creating Harmony Among Religions Goes in The Interest of The State”: A Concluding Speech by Honorable Dr. Arif Alvi, President Islamic Republic of Pakistan

I thank Implementation Minority Rights Forum (IMRF) and Ministry of religious affairs for organizing this conference and I welcome delegates from throughout the world who have come here.

When we talk about inter-faith harmony, this is a subject which is very dear to me. Every discussion starts from what God and Prophet Muhammad (PBUH) has ordained and practice which was prevalent in those times; then the history of inter-faith harmony in the sub-continent and then looking at Constitution of Pakistan. So, this is the general spread of my discussion with all of you.

I must start with what Holy Quran asks us to do justice in all affairs. The Quran says, “Do not let the hatred of the people deviate you from justice”. Then the Prophet (PBUH) said, “beware I myself shall awake the justice of the Almighty, the day of the judgment against the person who oppresses.

Ten to fifteen years back, I did some research on a document which exists in St. Catherine’s Monastery in Sinai. I call this document a charter of Christian-Muslim harmony. St. Catherine’s Church is established at a place where it is believed that God communicated with Moses at the burning bush. That document which contains stamp of Prophet Muhammad (PBUH) and another document which contains stamp of Hazrat Umer, the second Caliph. According to this document it was responsibility of the Muslims to safeguard Churches and protect Christians. Throughout the era of Islamic history, the rights of the minorities were reserved. Now coming to India, let me take it 70 or 80 years back. Sir Syed Ahmed Khan wrote in his pamphlet, “When the rulers do not take care of their people, it is natural that people revolt against the government. Now the Muslims in India are 14% of the total population.

In 1906, Sultan Mohammad Agha Khan, the Nawab of Dhaka organized a Conference of Muslims from all over India. All-India Muslim League (AIML), popularly known as the Muslim League was founded in Dhaka, British India (now in Bangladesh) The party’s chief aim was to promote and secure civil rights for Muslims.

Now when Pakistan was formed; it is incumbent on us to ensure that rights of the minorities be protected and therefore according to speech of Quaid-e-Azam dated 11 August, 1947, all are equal before the law. The same thing is mentioned in **Article 20 of Constitution of Pakistan** which guarantees freedom of religion. Pakistan is a signatory to the UN Charter of Human Rights. The government is under obligation to safeguard the fundamental rights of all without discrimination based on religion, faith, or belief.

Article 21 of Constitution of Pakistan, safeguard against taxation for purposes of any particular religion.

Article 25 of the Constitution of Pakistan, states "The State shall provide free and compulsory education to all children of the age of five to sixteen years in such manner as may be determined by law.”

Article 27 safeguard against discrimination in services, and **Article 36** states, “The State shall safeguard the legitimate rights and interests of minorities, including their due representation in the Federal and Provincial services”

To ensure representation of minorities ,10 seats for minorities in the National Assembly and four seats in the Senate have been reserved. But the Muslims in India are struggling for such rights.

There are issues in Pakistan. Everything is not fine. This is a struggle which is going on to ensure the fact that there should be harmony and people like you and leadership sitting from different faiths is responsible for that. I am glad that Government of Pakistan and primarily Prime Minister Imran Khan is committed for minorities. This is a struggle which will continue. There are differences within the Muslim community as well. But Pakistan is changing; Pakistan is

coming to a new era but at the same time we had made tremendous sacrifices. We have learnt that we cannot divide our people. Look at our Eastern borders, the things are happening which will create tension in India between majority and minorities. It is actually happening and to some extent laws are being changed. But when you see the laws are being changed in favor of majority to isolate the minority, that's a dangerous precedent. Mr. Imran Khan has spoken about it. We are not changing the laws in a negative direction in Pakistan. While in India laws are being changed giving negative direction.

I urge the political leadership of France “not to entrench discriminatory attitude against Muslims into laws” and warned that such steps would lead to serious repercussions in the shape of hatred and conflict. “You [France] need to bring people together and not to stamp a religion in a certain manner to create disharmony and bias.

The French legislation was not in line with the United Nations Charter and contradicted the spirit of social harmony that Europe previously instilled in its society. “Let there not be a retrogressive step for situations which arise out of animosity and for situations which are carried forward by the people who do not know about the real Islam.

The damage might not be evident at present, but would ultimately end up in a terrible scenario of hatred and hostility. “To label the entire religion in a different manner and to start taking precautions against the entire community sparks the fact that if not now, it will have very bad repercussions in the next 10 years.

The West was communicated by the government of Pakistan that blasphemy of Prophet Muhammad [(PBUH)] in the name of freedom of expression and religion was considered by entire Muslims Ummah an insult to the revered personality. The President emphasized that the world instead needed to divert energies on addressing other serious challenges such as climate change, poverty, hegemony, and exploitation. He said humanity needed to rise above its vested interests and live up to the ideals of mosque and church as no Prophet, whether Prophet Muhammad [(PBUH)] or Jesus Christ gave a message about animosity, instead, they spoke about peace among people.

The government believes in an emerging Pakistan with peace and harmony among people with all religions, faiths, and colors merged into the ideals of peace and prosperity. In Pakistan, we believe today, there is the morality behind every decision. At the same time, it is in our self-interest that the people of Pakistan must be together and, in all laws, and everything we do, we must ensure that we will promptly fight incidents raising differences,” There could be accidents and incidents attempting to create disharmony but the nation would fight those “very promptly”. The reconstitution of Minorities’ Rights Commission to protect the worship places of religious minorities is a positive step by the government. “Pakistan is entering a new era with lessons learned that we cannot live with divisions among our own people



DECLARATION OF THE CONFERENCE

To take appropriate measures to ensure the implementation of the General Assembly resolution 47/135 of 18th December, 1992 which reads as follows :-(with special reference to Religious Freedom and Rights of Minorities)

- a) Article 1 of Declaration on the Rights of Persons Belonging to National or Ethnic, Religious and Linguistic Minorities Adopted by General Assembly resolution 47/135 of 18th December, 1992.
 1. All member States shall protect the existence and national ethnic, cultural, religious and linguistic identity of minorities within their respective territories and shall encourage conditions or the promotion of that identity.
 2. States shall adopt appropriate legislative and other measures to achieve those ends.
- b) All member States should ensure implementation of the rights of Minorities according to United Nations Charter and constitutions of their respective countries.
- c) United Nations, European Union and Relevant Forums should organize such Conferences and must develop a strategic policy for implementation around the world.
- d) A Declaration executed by European union delegation to Pakistan in collaboration with interfaith council for peace and harmony Pakistan dated 09.12.2020 in Islamabad should be implemented in letter and spirit in Pakistan.
